F23/038 RECORD OF ATTENDANCE AND APOLOGIES

F23/039 DISCLOSABLE PECUNIARY INTEREST

Members were reminded that under the Localism Act 2011 (sections 26-37 and Schedule 4) and in accordance with the Council's Code of Conduct, they are required to declare any interests that are not currently entered in the member's register of interests or if he/she has not notified the Monitoring Officer of it. Requests for Dispensations should be made in writing to the Clerk in advance of the meeting.

F23/040 PUBLIC QUESTIONS

The grant applicant spoke to the committee about the Theatre Group grant application, explaining the benefit to young people and the programme that was planned.

F23/041 MINUTES

The committee received draft Minutes from the Finance and Governance Committee meeting on 5th June 2023 for approval.

PROPOSAL: It was proposed by Cllr K Straw that the draft minutes be accepted as a correct record of the meeting. This was seconded by Cllr Jackson, agreed unanimously, and so it was **RESOLVED**.

F23/042 COMMUNITY GRANTS

The Committee received a community grant application from the Broadclyst Theatre Group. The application was for £2,000 towards a summer project.

It was noted that the Theatre Group had submitted some of the requested accompanying documentation (a copy of its safeguarding policy and proof of PL Insurance); the absence of additional documents was explained in the application supporting statement supplied by the applicant.

The Clerk's report was as follows:

"[...] it is recommended that this application is approved in full at **£2,000**;

- a. that in this instance the Council records a discretionary exception from its grants policy rules 2.3b, 2.3d, 2.3e, 2.3f, which require applicants to submit the group's constitution, previous year's accounts, copy of latest annual accounts/latest bank statement/balance sheet, and equality / equal opportunities policy respectively;
- b. that the Group is invited to attend a future meeting to report back to the council on the project."

PROPOSAL: It was proposed by Cllr Massey to award the grant application. This was seconded by Cllr Jackson, agreed unanimously and so it was **RESOLVED**.
